# **OSHA Health and Safety Train-the-Trainer**

### **Updates from Washington**

It is likely that the next Environmental Workforce Development and Job Training Grant Request for Proposals (RFP) will be released in December, with awards announced in late spring or early summer. It's time to begin preparations for responding to the RFP. During the next PLC call we will begin discussing best practices in planning, delivering, and sustaining environmental workforce development and job training programs. We will also keep PLC members informed with updates from Washington.

#### **Program sustainability**

In previous PLC sessions, we discussed the importance of partnering with large institutional organizations such as city, county, or state government; community colleges; large community organizations and nonprofits; organized labor; and organizations funded by the Department of Labor. Having these large organizations act as the fiscal agent provides many leveraging opportunities, startup resources, and the best chance for obtaining legislative funding.

Legislative funding (currently extremely difficult to obtain) provides a continuing source of funding – year in and year out – with funds provided from the state, county, or city budgets. Additional funding may come from environmental fines and penalties (contact the Attorney General's office) or as part of larger programs funded with block grants. The goal of these strategies is to institutionalize the Environmental Workforce Development and Job Training Program.

In the absence of public money, it is important to "morph" into an existing institutionalized program. Such a program may exist in large community organizations, nonprofits, labor organizations, or community colleges. Many of these programs would consider incorporating environmental training into a larger Department of Labor Program such as Youth Build.

Clearly, an additional approach to sustained funding is reapplication for federal assistance, supplementing grant funds with additional leveraged resources. It should be noted that while some programs have been refunded as many as five times, the EPA Environmental Workforce Development and Job Training Program is not designed as a continuous source of funding and should not be considered as a preferred approach for program sustainability.

## Technical Assistance to Brownfields (TAB)

TAB provides a summary of remediation technologies. This is a useful document in understanding cleanup. TAB has completed 22 two-page citizen's guides related to innovative and established cleanup approaches. The new guides are designed to be used as a tool to communicate cleanup information to the public. The 22 guides are posted at the following Web sites:

Call the Mayor's office or office of economic development to see if a proposal has been submitted. Partner and coordinate early. This effort is an excellent start in developing a stakeholder network. Let them know you are thinking about an environmental workforce job development and training program. Ask them to be a partner.

<u>EPA Announces Opportunity to Apply for 2013 Environmental Justice Small Grants</u>
The U.S. Environmental Protection Agency (EPA) announced that it is seeking applicants for a total of

\$1.5 million in environmental justice small grants to be awarded in 2013. EPA's environmental justice efforts aim to ensure equal environmental and health protections for all Americans, regardless of race or socioeconomic status. The grants enable nonprofit organizations to conduct research, provide education, and develop solutions to local health and environmental issues in communities overburdened by harmful pollution. Grants are available for up to \$30,000 each.

The 2013 grant solicitation is now open and will close on Jan. 7, 2013. Applicants must be incorporated nonprofits or tribal organizations working to educate, empower, and enable their communities to understand and address local environmental and public health issues. EPA will host four pre-application teleconference calls on Oct. 30, 2012; Nov. 14, 2012; Dec. 1, 2012; and Dec. 13, 2012 to help applicants understand the requirements.
