#### Updates from Washington

It is now likely that the next Environmental Workforce Development and Job Training Grant Request for Proposals (RFP) will be released in January with awards in late spring or early summer. Delays in issuing RFPs are not unusual. PLC members will be sent a copy as soon as it is released. It's time to begin program planning now before the RFP is issued.

#### Things to do before the Request for Proposals is issued

1. Contact your EPA Regional Coordinator before the RFP is issued. Coordinators will not be able to discuss specific grants after the RFP is issued. Contact information is at the end of these notes.
2. Assess your community.
  - a. Check out the competition. Who trains locally?
  - b. Search employers as potential partners, mentors, and program contributors.
  - c. Research local government.
  - d. Find contacts in the Office of Economic Development.
  - e. Locate Brownfields contacts in the state and local Departments of Natural Resources.
  - f. Become familiar with locally funded Department of Labor programs
3. Consider potential partners: those to partner with, and those to coordinate and inform.
4. Search out organizations with federal grant and training experience as potential partners/mentors.
5. Review last year's Request for Proposals. Minor changes will be made in this year's review criteria.
6. If a previous submission was not funded, contact your EPA Regional Coordinator for a review before the 2013 RFP is issued.
7. Research previous grants or proposals for local area-wide Planning Grants, Assessment, Revolving Loan Fund, or Cleanup grants. Coordinate with the stakeholders in these grants.
8. Start developing a stakeholder network.
9. Sign up for *Brownfields 2013*. It is not too early. (<http://www.brownfieldsconference.org>)

### **Funding opportunities**

*2013 Environmental Justice Small Grants.* EPA announced that it is seeking applicants for a total of \$1.5 million in environmental justice small grants to be awarded in 2013. EPA's environmental justice efforts aim to ensure equal environmental and health protections for all Americans, regardless of race or socioeconomic status. The grants enable non-profit organizations to conduct research, provide education, and develop solutions to local health and environmental issues in communities overburdened by harmful pollution. Grants are available for up to \$30,000 each. The 2013 grant solicitation is now open and will close on Jan. 7, 2013. Applicants must be incorporated non-profits or tribal organizations working to educate, empower, and enable their communities to understand and address local environmental and public health issues. EPA will host four pre-application teleconference calls on Dec. 1, 2012; and Dec. 13, 2012 to help applicants understand the requirements.
