## **NOTES FROM SESSION 40**

This session was the first PLC session in this series (cycle 4). PLC sessions are held every two weeks on Wednesdays at 2:00pm EDT.

### **PLC Objective**

The Brownfields PLC allows stakeholders and interested participants access to informal discussions held every two weeks. The discussions are limited to 30 minutes, and are guided by the interests of the group. Guest mentors and experts may host some of the sessions, and others may be open discussions on various topics. Each session is recorded, and post-session notes are provided for those not able to attend. Email contributions between PLC meetings are encouraged and will be shared with the group.

The objective of the PLC is to promote and share innovative strategies among Brownfields job training communities, and provide assistance to new communities interested in developing environmental job training programs.

### **Status of the current EPA grant review process**

Over 100 submissions were received. The first cut will eliminate programs which did not meet qualifying criteria. Remaining proposals will be evaluated based on the ranking criteria with a final determination made by EPA staff. Anticipated date of award announcement is June, 2011.

### **Brownfields Job Placement Strategies**

Thanks to Michael Goldstein for his briefing on the job placement effort being planned by the Florida Brownfields Association (FBA). The FBA is a non-profit, volunteer, service organization dedicated to advancing the cleanup and redevelopment of Brownfields in Florida (<http://www.floridabrownfields.org/>). Members of this organization consist of stakeholders associated with Brownfields projects in Florida. Such an organization can provide enormous benefits for surrounding environmental training programs. Opportunities from leveraging resources to advisory boards to potential employers lay within this organization.

Michael and his associates are investigating the possibility of establishing an environmental job bank to assist in matching trained workers with potential employers. Such a strategy will not only help Florida's job training programs with placement, but can also contribute to a statewide labor market assessment

and assist in guiding curriculum and certification offerings.
