2. HMTRI NEWS

All of us at HMTRI would like to reach out to everyone able to attend the 2020 Virtual Annual All-Grantee Meeting. Without your participation, this meeting would not be possible. It was an ambitious undertaking asking participants to attend over nine hours ZOOM over the course of three days.

To those grantees who sent in PowerPoints, videos and interviews we say "Thank you." The videos shared at the "Student Perspectives" and "After Hours" sessions underscore the impact EWDJT is having on people's lives across the country.

To our co-facilitators and presenters, we also say "Thank you," for sharing your knowledge and experience with other grantees. A willingness to help others become the best grantee they can be makes this program special.

And of course, we cannot leave out our EPA and NIEHS partners. Sharing their knowledge and experience provides EWDJT grantees access to the latest news and technology in environmental training, health and safety.

3. PLC QUESTIONS

I know this year's EWDJT grant applications are due by September 22. Wondering if we know when the next round of funding will be announced? We're not certain if we are going to apply for funding this year or wait until the next round?

Regarding your question on the next EPA RFA, depending on the EPA budget and internal priorities, past EWDJT competitions occurred on an annual basis. Last fall, twenty six FY20 awards were announced. FY21 applications due this September will be awarded in November or December of this year. It is highly speculative, but if there is a FY22 competition, it will likely have a schedule similar to this year's.

Our advice is to submit an FY21 proposal whether or not if it's not your best shot. Submitting a proposal, even if unfunded, gives applicants a chance to debrief with Regional Coordinators. Proposal strengths and weaknesses will be discussed. It will also put your organization on EPA's "short list" of interested candidates for the next competition. Many proposals fail the first year only to be funded on the next try. EPA highly encourages unfunded EWDJT applicants to expand their proposals and reapply during the next competition.

Could you tell me if the recording of the All-Grantee meeting is available and if so, where to access it?

4. STATUS OF EWDJT AUGUST 19, 2020

Anecdotal comments and observations from this week's PLC .

- Grantees are reporting that they will be commencing classes August 24th with masks and social distancing on a limited basis depending on local public health concerns and organizational policies.
- Those offering face-to-face training have reduced class sizes, masks and social distancing.

- For those opening, orientation, remedial education and life skills appear to be delivered first.
- Concern continues regarding team oriented exercises.
- HAZWOPPER (1920.120), asbestos and lead with PPE and decontamination exercises are of particular concern.
- A disparity is developing regarding public health concerns and regulations affecting face-to-face and contact instruction such as 1910.120, asbestos and lead worker.
- Lack of equipment, internet access and computer skills among the EWDJT participant population will limit the number of EWDJT programs able to provide online training.
- Most EWDJT program staff are continuing administrative operations including program planning, partnership communications, limited recruitment and placement activities.
- A number of questions regarding threshold requirements for alternative training plans are being discussed.

5. THINGS TO DO NOW

Double check your application submission process

Important: Double check the person assigned to submit your proposal. Have them log on and insure your credentials are current and that submission procedures have not changed since a grant application was last submitted. **For organizations new to federal grants, the registration process “from scratch” may take a month or more to complete.** Occasionally, technical and other issues arise when using www.grants.gov. We suggest a “dry run” even if the account has been used in the past. **Applicants must use their accounts at least once per year to remain active. Important note: We have been informed that grants.gov will be down for maintenance September 19th to the 21st. You will need to submit your grant early.**

Review and verify the ability to pass Threshold Criteria

Threshold Criteria are critical and reviewed on a “pass/fail” basis, it is important that you provide **all** the information requested. All Threshold Criteria must be satisfied to pass the screen. **It is extremely important that grant writers pay attention, fully understand and provide a response to the information requested.** If you have questions regarding your response to the Threshold Criteria, do not hesitate to call your Regional Coordinator for clarification. Contact information is presented in section 10 of these post session notes. Here is a quick summary of the nine Threshold Criteria necessary for proposals to proceed to the next step in proposal evaluation. These criteria are described in detail on page 13 of the [RFA](#).

- Applicants must be eligible to apply for the EWDJT program
- Applicants must demonstrate that the EWDJT program will not duplicate other Federally funded environmental job training programs

- HAZWOPER training is required as part of the core curriculum
- Federal funds requested must not exceed \$200,000
- Page counts and formats must conform to guideline standards
- A curriculum chart with cost estimates for each course
- This year applications must include two separate plans for delivering training
- Target area
- Funded proposals in the FY20 cohort are not eligible to apply for FY21 funding

Schedule proposal development deliverables from now to September 14th

Don't get caught off guard. We will repeat. Grants.gov is expected to be down for maintenance September 19th to the 21st. You will need to submit your grant early. We suggest no later than the 14th. If multiple staff members are participating in proposal development, it is important that you have specific deliverables defined and hard deadlines established. Partnership development including recruitment of potential employers, an advisory committee, leveraged partners and community supporters is time intensive and should be underway.

Our current "best guess schedule" for application submission, award and program implementation is flexible but could look like this:

- EPA Request for Applications posted on grants.gov – July 27th
- Proposal planning and team building pre grant preparation – Ongoing
- Community relationship and partnership development – Ongoing
- **Proposals due – September 22nd (submit early)**
- Threshold criteria (Pass Fail) notifications of application rejection – Second week of October
- Proposal evaluations – November – December, 2020
- Award announcements – February, 2021
- Finalization of work plans and award finalization – Early Spring, 2021
- Authorization to spend funds –April - May, 2021
- Program planning, partnership coordination and scheduling – Spring – Summer, 2021
- Community awareness, student recruitment and screening – Summer
- First year training cohorts begin – Summer, Fall, 2021
- ACRES and Quarterly reports – Due quarterly after award finalization

6. INTRODUCTION TO RANKING CRITERIA

After passing Threshold Criteria, scoring maximum points on Ranking Criteria determines those applications on the short list for funding consideration. The top 15 scores (with special considerations), will share the \$3 million allocated to EWDJT in FY21. As few as two points have made a difference between funded and unfunded proposals. In order to be in the top 15 proposals, applicants must consider the following:

- Seek every point possible
- Leave no question unanswered
- Answer each question independently

- Do not assume evaluators know anything about your program. Many may not be familiar with EWDJT.
- Be as specific as possible when providing information
- Be quantitative rather than subjective. Use numbers whenever possible.
- Include partner names and secure MOUs.
- Hold public meetings
- Don't forget to involve the community
- Engage city government
- Never exclude the Workforce Investment Board (WIB)

A suggested approach to researching and gathering data for the RFA proposal is to group topic areas. Address each topic group in depth and then use that information as a reference when reconstructing a response to each Ranking Criteria as the grant is written. This approach allows for a "deep dive" in information gathering for each topic area. For our PLC sessions, Ranking Criteria has been divided into the Ranking Criteria topic areas below. Today we began discussing community relationships (in yellow) and labor market assessments (in green).

109 Ranking Criteria points for discussion

- 1.A. Community Description (10 points)
 - 1.B. Labor Market Demand (10 points)
 - 2. Training Program Description (10 points)
 - 3. Budget (6 points)
 - 4. Program Structure, Anticipated Outputs and Outcomes (19 points)
 - 5.A. Collaboration with Entities Involved with Local Remediation Activities and Environmental Projects (8 points)
 - 5.B. Community Partnership Building (8 points)
 - 5.C. Employer Involvement (12 points)
 - 6. Leveraging (6 points)
 - 7. Programmatic Capability (20 points)
- Other Factors

Community assessment will be addressed first.

Digging into and developing community relationships will allow grant writers the information to respond to both of these Ranking criteria. Understanding and partnering with community organizations will provide grant writers ample and detailed information regarding the proposed target community. Here are the two community related Ranking Criteria.

- 1.A. Community Description (10 points)
- 5.B. Community Partnership Building (8 points)

1.A. Community Description (10 points)

The depth and degree of environmental and economic challenges confronting your city/town/geographic area and the specific area where you plan to serve (3 points);

- The impact of current community challenges on residents and an explanation of how/why you selected your target area. (3 points)
- Demographic statistics provided compare to city, state, and/or national averages and how well they demonstrate a community indicative of need. (2 points)
- The extent to which the application seeks to serve target communities with high indicators of need (such as high rates of unemployed individuals, dislocated workers, individuals laid off as a result of recent manufacturing plant closures, severely under-employed individuals or unemployed individuals, low income and minority residents of environmentally impacted communities, veterans, and individuals with little to no advanced education). (2 points)

5.B. Community Partnership Building (8 points)

- The extent to which the applicant collaborates with the affected community in your proposed job training program, including efforts made to notify and involve the local community, and/or hold any public comment sessions in the during the development of your application. (2 points); e.g., local community groups, workforce investment boards (WIBs), One Stop Centers, and academic institutions located in or near the target community.
- The level of involvement of these organizations in your program and the benefit partnerships will bring to your program and graduates. (2 points)
- Commitments made to support your program and letters of support from community partners. (2 points)
- The quality and applicability of the information provided in letters of support from community partners who made any commitments, detailing the depth and degree to which they intend on being involved in your program. Letters of support provided in the attachments should be consistent with the commitments or statements made within the Narrative. (2 points)

Second, employer relationships are key in scoring points in several of the Ranking Criteria.

Developing relationships and partnerships with employers will allow grant writers to provide numbers, names, partnerships and letters of support needed to respond to each of the following Ranking Criteria.

1.B. Labor Market Demand (10 points)

5.A Collaboration with Entities Involved with Local Remediation Activities and Environmental Projects (8 points)

5.C. Employer Involvement (12 points)

Specifically here are the Ranking Criteria related to employer relationships and labor market demand.

1A. Labor Market Demand (10 points)

- The depth and degree you conducted a labor market assessment to gain an understanding of the current job market in your target area. (3 points)
- The methods used to conduct your assessment. (3 points)
- The extent to which the labor market assessment resulted in an indication that your target area has the demand for a skilled environmental workforce your training program would provide. (2 points)
- The extent to which the results of your assessment were incorporated into the development of your application and training program curriculum. (2 points)

5.A .Collaboration with Entities Involved with Local Remediation Activities and Environmental Projects (8 points)

- The extent to which the applicant collaborates with entities performing environmental work in and around the target area including, but not limited to, brownfields assessment, revolving loan fund, cleanup, and area-wide planning grant recipients, Superfund site cleanup contractors, EPA-funded state or tribal regulated corrective action or landfill closure projects, recycling facility operators, or personnel from city-operated wastewater treatment facilities in your community. (2 points)
- The quality of the partnership(s) and benefits these partnerships may bring to your program and graduates. (2 points)
- The number and types of entities which have made commitments to support your program. (2 points)
- The quality and applicability of the information provided in letters of support from entities which have made any commitments, detailing the depth and degree to which they intend on being involved in your program. Letters of support provided in the attachments should be consistent with the commitments or statements made within the Narrative. (2 points)

5.C. Employer Involvement (12 points)

- The extent to which the applicant collaborates with employers within or near the target area and, if applicable, any employer partnerships that have resulted in previous graduates of your job training program being hired. (3 points)
- The depth and degree of employer involvement in the design of your program including, but not limited to, meeting dates, advisory council participation, and curriculum development. (3 points)
- Level of involvement and commitment from employer partners that will enhance a graduate's chance of success including, but not limited to, commitments to interview students, hire graduates, provide on-the-job training, and/or mentoring. (3 points)
- The quality and applicability of the information provided in letters of support from employers who have made any commitments, detailing the depth and degree to which they intend to be involved in your program. Letters of support provided in the attachments should be consistent with the commitments or statements made within the Narrative. Commitments accompanied by letters of support affirming these commitments may garner more points. (3 points)

By combining and researching these Ranking Criteria evaluation topics before responding to the final proposal, grant writers will avoid contradiction and be able to provide specific and detailed answers to information requests.

9. FUNDING AND LEVERAGING OPPORTUNITIES

[FY 2021 Supporting Equitable Development and Environmental Justice in Brownfields Communities Grant Guidelines](#)

Submission deadline - September, 21, 2020

This notice announces the availability of funds and solicits applications from eligible entities, including nonprofit organizations, to provide direct technical assistance to communities nationwide on the integration of environmental justice and equitable development when developing solutions to brownfields cleanup and revitalization challenges. EPA anticipates awarding one grant for an estimated \$600,000. The award is anticipated to be funded incrementally on an annual basis over three years, at approximately \$200,000 per year. 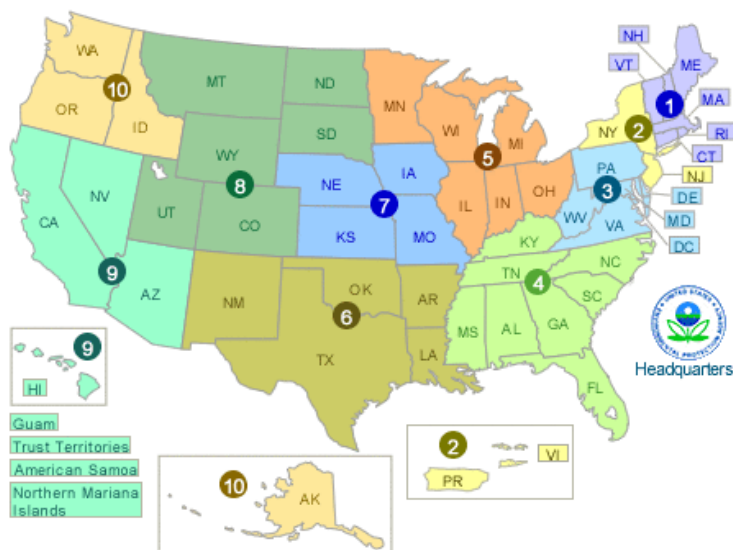
