# Moving forward on proposal development

The latest "best guess schedule" (nothing official) puts new urgency on planning and preparation for the FY21 grant cycle. If an RFA (request for proposals) is issued in June, applicants might anticipate the following schedule for application submission, award and program implementation:

- Proposal planning and team building ongoing
- Community relationship and partnership development ongoing
- EPA request for proposals June-July, 2020
- Proposals due August September, 2020
- Proposal evaluations Fall Winter, 2020
- Awards, finalization of work plans and authorization to spend funds Spring, 2021
- Community awareness, student recruitment, and screening Summer, 2021
- First year training cohorts Summer, Fall, 2021

# West End Neighborhood House

West End is committed to the safety and well-being of customers, staff, volunteers and broader community. The organization has helped overcome disasters, tragedies and epidemics since the Spanish Influenza of 1918. During the current crisis, West End is focused on 2 primary goals: (1) Serving the community; and (2) Ensuring the financial stability and health of employees.

Located in the city of Wilmington's historic 'Little Italy' district, West End Neighborhood House has been improving the lives of an ethnically, economically and culturally diverse community since 1883. In 2018, the agency served over 10,000 individuals.

# A quick look at West End's EWDJT program

- West End Neighborhood House, Inc. plans to train 55 students and place at least 45 graduates in environmental jobs
- West End Neighborhood House, Inc. is targeting residents of communities that have been historically affected by pollution, disinvestment, and solid/hazardous waste in Wilmington, Delaware
- The core training program includes 123 hours of instruction
  - 40-hour HAZWOPER
  - OSHA general industry
  - OSHA forklift operator
  - EPA lead renovation, repair, and paint
  - Asbestos worker
  - Mold and microbial worker
  - OSHA confined space entry
  - Soil sampling
  - Participants who complete the training will earn twelve certifications
- Key partners include
  - o Delaware Department of Natural Resources and Environmental Control
  - BrightFields, Inc.
  - Guardian Environmental Services
  - Environmental Staffing
  - o Environmental Alliance, Inc.
  - East Coast D.E.S
  - ASTEC Environmental

Auberle was founded through the legacy and generosity of Pauline Auberle, a McKeesport resident, who upon her death willed money and land to the Bishop of the Catholic Diocese of Pittsburgh to start a "home" for boys. In 1948, the Pauline Auberle Memorial Foundation was incorporated and in 1952 the realization of Pauline's dream took place when Auberle was constructed and opened its doors.

Auberle became a home for adolescent males and was known as the "Boystown of the East." For years, Auberle was dedicated exclusively to providing care to boys. The late 1980s and early 1990s witnessed the planned growth of Auberle into new service areas. In addition to our residential programs for boys and the launch of adolescent male group homes, there was a new focus on keeping families together and providing services to girls and young women.

Today, programming continues to evolve to meet critical needs in the community such as foster care, workforce development, mental health and drug and alcohol counseling, school-based therapy, housing and shelter. The Employment Institute offers 13 nationally recognized certification programs, employment opportunities, life skills and work readiness training, education services and employment exposure/search services. With 102 employing partners and 89 referral agencies throughout the region, Auberle is a highly respected and award-winning workforce development program that helps individuals find a good paying and sustainable career.

When individuals graduate from one of the Employment Institute's programs, they are prepared to take on the real world of work and have the training to succeed.

A quick look at Auberle's EWDJT program

- Auberle plans to train 50 students and place at least 35 graduates in environmental jobs
- Auberle is targeting unemployed, underemployed and at-risk individuals in Allegheny County
- The training program includes 102 hours of instruction
  - 40-hour HAZWOPER
  - o 32-hour asbestos abatement
  - Confined space entry
  - OSHA-10 safety
  - o OSHA 30
  - Asbestos Awareness
  - Lead Awareness
  - Confined Space
  - o Flagger
- Training will take place in both a classroom setting and at hands-on worksites, and will include mock remediation tests (a strategy in progress)

- Participants who complete the training will earn five federal certifications

As the COVID-19 crisis has closed many grantees, Auberle has been able to continue working with numerous partners, employers and program participants. The nature of their community service charter requires Auberle to remain open with strict public health guidance including daily temperature checks.

# 5. THE STATUS OF EWDJT MAY 27<sup>TH</sup>, 2020

EWDJT programs are more important today than ever before. The EWDJT

program provides Environmental Justice opportunities for community residents disproportionately impacted by environmental degradation, the pandemic and resulting recession. Unfortunately, EWDJT programs are centered around, networking, teambuilding, hands on and peer-to-peer learning. With most programs either suspended or proceeding with muted activity, here are the situations in which EWDJT grantees find themselves.

- Organizations interested in starting or continuing a program and are planning on responding to the next RFA
- Grantees receiving funding during the FY20 cohort and are planning the first round of training
- EWDJT programs that have been interrupted due to COVID-19 and public health guidelines
- Programs between training cohorts, in the process of placing graduates or assisting laid off graduates seeking re-employment

Organizations interested in starting an EWDJT program or expanding an existing program are beginning preparations to leverage the upcoming EPA environmental workforce development FY21 funding cycle. The new round of funding is expected this summer for training to begin during the summer of 2021. While the current COVID-19 crisis may be under control by then, rethinking EWDJT may provide an opportunity for new and innovative approaches to environmental training.

Grantees receiving funding during the FY20 cohort are planning the first round of training. New grantees are looking for guidance on transitioning to distance learning, smaller training cohorts, maintaining physical distance, team building strategies, student recruitment, screening, peer to peer learning and classroom safety.

Programs disrupted in the middle of training have the biggest challenge. Keeping students engaged. Often, students may not have access to computers, Internet, phones or cell service. During a recent HMTRI scan, a grantee noted the following. *"Many do not have reliable phone service, especially now that many have been laid off and can't pay their phone bills. Many use a Wi-Fi number instead of traditional phone service, but the only reliable places to get free service are downtown in public areas which may be closed (government buildings and libraries which are currently shut down in our city, cafes*  which you can't sit down in) or which people may be avoiding due to social distancing precautions, and that at the least aren't conducive to learning. This is our biggest hurdle with distance learning - it isn't very accessible to the vulnerable population we serve..." Maintaining student retention, services and student resources are of major concern.

Programs between training cohorts, in the process of placing graduates or assisting laid-off alumni seeking re-employment can continue during the COVID-19 crisis. For those in the middle of placement, job availability during the pandemic can be challenging but new jobs are also being created. Rethinking potential employers and marketing skill sets are activities to explore and expand.

# Grant writing proficiency

If this is the first time submitting an EWDJT proposal, applicants may want to consider working with an organization or individual experienced in submitting Federal grants. Grant writing and submission is perhaps the one area where experienced applicants may have an advantage over organizations that have never submitted an EWDJT proposal. Applicants need to understand that reviewers evaluate programs based on the written content of the application. The best, most comprehensive program is not likely to be funded unless the quality of that program is expressed in the written application. As the early stages of program development begin, careful consideration needs to be given to the grant writing and submission process.

Prospective grantees and those who have been away must re-learn their way around Grants.gov. Fortunately, everything a grantee needs to know is at this site. The objective of grants.gov is to provide a common website for federal agencies to post discretionary funding opportunities and for grantees to find and apply to them. Grants.gov is an E-Government initiative operating under the governance of the Office of Management and Budget. Grants.gov houses information on over 1,000 grant programs including EPA grants. # EPA Provides Grant Funding to Support Environmental Justice Communities Impacted by COVID-19

The U.S. Environmental Protection Agency (EPA) is working to improve the environment and public health conditions of low-income and minority communities through our daily efforts to ensure all Americans have clean air, safe water, and access to information to make decisions to protect personal and public health. In response to the COVID-19 public health emergency, EPA is making \$1 million in grant funding available to states to help local environmental justice communities address COVID-19 concerns faced by low-income and minority communities. Through the State Environmental Justice Cooperative Agreement Program, EPA will provide funds to states, local governments, tribes and U.S. territories to work collaboratively with environmental justice communities to understand, promote and integrate approaches to provide meaningful and measurable improvements to public health and the environment.

"Environmental justice grants aim to support public education, training, and emergency planning for communities across the country impacted by COVID-19, regardless of their zip code," said EPA Administrator Andrew Wheeler. "These grants are part of EPA's effort to actively fight the COVID-19 pandemic that is having a disproportionate impact on low-income and minority communities."

The grant funding will be used to support public education, training, and emergency planning for communities impacted by COVID-19. Projects could include sharing information related to EPA-approved disinfectants to combat COVID-19; addressing increased exposure of residents to in-home pollutants and healthy housing issues; and training community health workers.

EPA anticipates awarding five grants of approximately \$200,000 each for up to a two-year funding period. The agency encourages applicants to develop innovative plans and processes to conduct effective outreach to underserved communities, especially in places where Internet access may not be readily available to all residents.

Interested applicants must submit proposal packages on or before June 30, 2020 to be considered for the available funding.


