2. News from HMTRI

Mark your calendar

HMTRI is planning the annual virtual All Grantee Meeting May 4th, 5th and 6th. 12:00 to 3:00 pm Eastern each day

This year's All Grantee Meeting will be a Zoom event with a format similar to last year's. Sessions are scheduled from 12:00 to 3:00 pm Eastern each day. The event will feature networking opportunities with EPA staff, Regional Coordinators, current, past and prospective grantees, student videos, break-out rooms for discussion and grantee tours. HMTRI has completed a scan to determine topics and talking points of interest. In the coming weeks, we will be recruiting presenters and collecting videos to showcase their program with meeting participants.

All Grantee Meeting topic scan

Thank you for your input regarding topics you would like to cover at this year's All Grantee Meeting. Currently we are planning 3 regional breakout sessions, 10 plenary sessions and 15 breakout sessions that will cover the topics and talking points suggested. Our after hour sessions will feature home videos and grantee tours.

3. Questions from PLC participants

Question: I just heard we got the grant! Do you know the start and end dates for the grants just announced?

Response: Congratulations... but hold on.... Applications recommended for funding have been announced, however, there is still a ways to go before you can start spending money. Some awardees may have already been congratulated by their EPA Regional Coordinator (those who have been refunded and are on Regional contact lists). All selected organizations will receive

official notice and a grant package package shortly. In some cases, there may be an official announcement and or a photo op with public officials. (We love photo ops). Make sure the individual submitting the grant is aware (principal contacts have been known to change jobs). Several dates are relevant to administration of the grant and ability to access funding.

- Date of the announcement– March 11th, 2021 **FY 21 EPA EWDJT announcements**
- Project period Before September 31st
- Budget period Usually same as Project Period

The project period and budget period are usually the same and scheduled about 2+ months after the announcements but before the end of the fiscal year (September 31). Work plans, terms and conditions, final negotiations and spending accounts need to be completed before authorization to spend funds can be made. We would suggest contacting the Regional Coordinator if you need to spend funds before final authorization to spend funds is given. EPA can grant permission (in special circumstances) to spend funds up to 90 days before a final authorization to spend funds is authorized. When the project period and budget period is set, the fun begins with milestones completed and quarterly reports every quarter. Best wishes ... Each grant will have different dates, but here is a general timeline.

FY21 EWDJT timeline

The timeline for each grant depends on the official award date and authorization to spend funds. A hypothetical schedule might look like the time line presented below. The FY21 EWDJT grant cycle extends from the official start date for three years. The first two years should focus on program development and training delivery with a final year for additional training, placement, tracking and program sustainability.

Fall 2020

• Applicants have 60 days to write and submit their applications

March 11, 2021

• 18 proposals recommended for FY21 funding

April, 2021

- Regional Coordinators contact successful and unfunded applicants
- *Grant packages are sent to successful applicants*
- Award letter and acceptance by applicant
- All applicants have an opportunity to schedule a debriefing and review of their application

May -September, 2021

- Post award meetings with Advisory Board, partners, instructors and community stakeholder
- Work plans reviewed and approved
- Terms and Conditions finalized
- Grant accepted by submitting organization
- Funding authorized
- Official notice that funds are available for spending
- Program planning preparation for the first cohort under the new grant

October ++, 2021-2022

- Assessment, recruitment and first cohort under the new grant begins
- Quarterly and ACRES reporting due every quarter
- Training and curriculum adjustments from lessons learned

- Recruitment and training continues
- Partnership and resource leveraging continues
- First and second year of the grant focused on training and placement

2023

- Preparation for program expansions, sustainability and grant refunding
- Partnership development continues

2023-2024

- Last year of the grant, training "windup" placement, tracking
- Continued development of Federal and local funding for program expansion

4. FY21 EWDJT funding announcements

Congratulations to the 18 EWDJT programs recommended for EPA funding. Some applicants will be establishing new programs, others building on existing programs including returning alumni not funded in the last three years.

Keep in mind that funding recommendations are based on an objective evaluation of submitted written proposals applications. Many excellent and deserving programs may be overlooked using this process. Unsuccessful applications are not necessarily a reflection on the effectiveness or quality of a program but rather a reflection on the response to evaluation criteria in relation to other proposals submitted. For this reason, we strongly suggest those not considered for funding this cycle continue their efforts in establishing EWDJT in their community. We encourage organizations to continue participating in All Grantee Meetings, tuning into the PLC and attending Brownfield conferences and local events. This summer applicants will have another opportunity to apply for FY22 environmental workforce training support.

Including this year's announcements, EPA has awarded more than 353 grants totaling over \$75 million. Over 18,700 individuals have been trained and 13,751 have been placed in careers related to land remediation, environmental health and safety. This year's grantees will add another 900 graduates to that total. Here is snapshot of EPA funding awards over the past six years. Note EWDJT competition was suspended in FY19, only to resume with an early and expanded competition in 2020.

With a renewed emphasis on Environmental Justice and workforce development, we are anticipating increased interest this summer with new, existing and legacy programs applying for FY22 Funding.

5. Funded/not funded? - Things to do now

Funded – now what?

Remember... Successful proposals have been recommended for funding but funds are not yet available to spend.

Before the formal award is made and drawdowns begin, several important milestones must be completed.

- Terms and Conditions with approved work plans should be the primary focus during the months ahead.
- It's time to spread the good news and alert management of the tasks ahead.
- Time to pull out the grant, reviewing commitments and deliverables made in the proposal.
- Regional Coordinators will contact and send a package or templet with all the information the EPA grants office needs to process the grant.
- This is the time to refine budgets and work plan with revisions if necessary.
- After the award letter has been received, the principal grant recipient must acknowledge
 acceptance of the terms and conditions. In the case of governmental organizations,
 acceptance may need approval by City Council. Community colleges, nonprofit and
 tribes may need approval from the Board of Directors, Tribal Council or Director. Don't
 assume these approvals will be automatic.
- After contacting the Regional Coordinator, it is wise to set up a meeting with partners and stakeholders with an active role in the program.

- After grant processing has been completed and payment accounts established, grantees will receive authorization spend funds.
- Note: under special circumstances (such as budgeting for Brownfields 2021 Regional Coordinators may allow expenditure of funds up to 90 days prior to final authorization with special permission. It is important to work with the Regional Coordinator on this matter.

Unfunded programs

As previously noted, many excellent and deserving programs have likely been overlooked. Unsuccessful applications are not necessarily a reflection on the effectiveness or quality of a program but rather a reflection on the response to ranking criteria in relation to other proposals submitted. As demonstrated in the past, first time applicants often need a second try before submitting a successful application. Alumni grantees often need to rethink their partnerships and expand the scope of their proposals. In each case, we offer the following advice.

- Continue expanding the existing proposal the FY22 RFA is only months away.
- Update labor market and community assessments.
- Relate program objectives to labor market and community needs.
- Maintain coordination with partners expanding the scope of their involvement.
- Revisit curriculum offerings and delivery based on current needs and public health concerns.
- Contact Regional Coordinators for a critical proposal review.
- Stay engaged with HMTRI meetings, the PLC, national and local brownfield conferences.

6. Revisiting the HMTRI March 10th in person training webinar

As discussed in this week's PLC call, In-person training appears to be the primary method for environmental workforce training delivery as public health concern over virus transmission begins to abate. On March 10th HMTRI facilitated a Mid-Year Webinar panel of EWDJT grantees to explore lessons learned during the global pandemic. Thanks go out to the panel which included Elizabeth Cornell from Limitless Vistas in New Orleans, LA, Ken Alexander from RecycleForce in Indianapolis, IN, and Rene Dulle from St. Louis Community College, St. Louis, MO. A recording of the webinar will be posted on the Brownfields Toolbox. To explore this topic in more detail, the January issue of CONNECT News discusses public health concerns during the COVID-19 pandemic and strategies for continued operation of EWDJT programs.

EJ grant opportunities

Request proposal packages on or before May 7

The U.S. Environmental Protection Agency (EPA) has announced the availability of up to \$6 million in grant funding under The Environmental Justice Collaborative Problem-Solving (EJCPS) Cooperative Agreement Program and The Environmental Justice Small Grants (EJSG) Program.

"These grants are crucial to supporting vulnerable and overburdened communities disproportionately affected by environmental health risks," said Office of Environmental Justice Director Matthew Tejada. "With renewed leadership to address environmental justice under the Biden-Harris Administration, we are excited to support community efforts to address historically challenging issues."

EPA will be giving special consideration to the following focus areas:

- Addressing COVID-19 concerns faced by low-income communities and communities of color
- Climate Change and Natural Disaster Resiliency outreach and planning
- New applicants to either opportunity
- Ports Initiative to assist people living and working near ports across the country
- Small non-profits

The EJCPS Cooperative Agreement Program's total estimated funding for this opportunity is approximately \$3,200,000. EPA anticipates awarding two cooperative agreements of \$160,000 each within each of the 10 EPA Regions.

The EJSG Program estimates approximately \$2,800,000 will be awarded to approximately five applications per EPA region in amounts of up to \$50,000 per award. This includes the EPA's Ports Initiative program which anticipates funding up to six additional projects that address clean air issues at coastal and inland ports or rail yards. Applicants interested in either opportunity must submit proposal packages on or before May 7, 2021 to be considered for the available funding. Applicants should plan for projects to begin on October 1, 2021.

CPWR is now accepting applications for funding from the Small Study Program Open applications accepted

CPWR's Small Study Program provides seed money of up to \$30,000 to investigate promising new research initiatives. Many major research projects began with a Small Study to demonstrate its viability or test the approach, and other studies have resulted in important stand-alone projects. A survey of researchers funded under this program found that more than 60 percent had published their findings in peer-reviewed journals.

How to apply for a Small Study Grant

Researchers interested in funding should review the Small Study Guidelines, which explain the requirements and process in detail. Applications are accepted and reviewed on a rolling basis and can come from investigators from a wide range of disciplines, including applied computer sciences, communication sciences, construction management, consumer marketing, economics, engineering, psychology, and work organization. We also welcome innovative proposals from occupational safety and health researchers, ergonomists, epidemiologists, researchers partnering with industry practitioners, and others.


