Several considerations were made related to the current, and anticipated, Coronavirus (COVID-19) situation. We have rescheduled Brownfields 2021from its December 8 - 11, 2021, in Oklahoma City to August 16-19, 2022. Travel scholarships will soon reopen. # OSHA Health and Safety Instructor Training

The Community College Consortium for Health and Safety Training (CCCHST) Instructors are prepared through a 10-day Train-the-Trainer Program called the GreatEST Institute (Great Environmental Safety Training Institute) to deliver required certifications for public and private responders and workers including:

- 40-hour Waste Site Worker Health and Safety
- 24-hour Industrial Emergency Response
- DOT Haz Mat Awareness
- Confined Space Non Entry Rescue
- Hazard Awareness and Communication
- Disaster Site Worker Awareness

Instructors use CCCHST curriculum to train workers and responders in their local area and report to PETE the number of courses they provide, for which they are provided a small reimbursement. PETE reports these numbers to NIEHS. CCCHST members may charge for the courses offered in their local area. Instructors reporting numbers may return at least every two years for Instructor Refresher training offered at colleges across the nation.

CCCHST is sponsored by the Partnership for Environmental Technology Education (PETE) headquartered in South Portland, Maine. PETE is one of twenty-two affiliated councils of the 1,150-member American Association of Community Colleges (AACC) and the only council whose core mission is environmental, health, safety and security training. PETE network of community, technical, U.S. territory and tribal college members for whom PETE provides faculty development programs, workshops, and institutes. This program is supported with grant funding from the National Institute for Environmental Health Sciences (NIEHS).

# Cecilia Martinez is leaving her post as the senior Director for Environmental Justice at the Council on Environmental Quality

Last week President Joe Biden's top environmental justice official left the administration less than one full year into his presidency. Cecilia Martinez, who is leaving her post as the senior director for environmental justice at the Council on Environmental Quality, has largely been credited with shaping much of President Biden's environmental justice aspirations. In 2020, she helped develop then-candidate Joe Biden's environmental goals and since his election the Justice40 program. The White House has blown by deadlines related to the program, such as releasing its screening tool that is meant to identify communities most in need of such investments, and has also failed to explicitly define what types of communities would be tagged as "disadvantaged." Applicants participating in the FY22 Job Training program will recall using the EJ Screening Tool developed by the EPA Office of Environmental Justice to identify disadvantaged target communities.

# 4. FY22 environmental job training timeline and things to do now

For each individual grant, the FY22 grant cycle timeline depends on the award date and when applicants are authorized to spend funds. The first two years focus on program development, training delivery and placement. A final year has been added for additional training, placement, tracking and program sustainability. Milestones for the FY22 JT cycle might look like the schedule below.

#### January-February 2022

- Evaluation Criteria reviews continue.
- Keep in touch with key partners. Those providing letters of support may be contacted regarding their commitment to your program.
- Brief your advisory committee on the progress of the grant application. We are only two months away from funding announcements.

## March - April 2022

- Pending final review, 15 programs are recommended for FY22 funding consideration.
- Successful and unfunded applicants are notified if their program has been recommended for funding.
- Funded programs will by contacted by Regional Coordinators with grant packages to begin the funding process.
- Unfunded programs need to schedule debriefing sessions with their Regional Coordinator. These sessions are important in that Requests for FY23 applications are just a few months away.

#### May 4, 2022

- HMTRI Virtual Brainstorming Workshop- A virtual Mid-Year Brainstorming workshop will examine three
  critical issues for job training success at this point in the training cycle collect videos to share during an
  after-hours session.
- Begin preparing for the FY23 Job Training RFA to be announced this summer. EPA provides only sixty days
  to respond to RFA guidelines which is not nearly enough time to develop partnerships and write a
  successful application.

#### August 16-19, 2022

# Summer 2022

- Grant packages and work plans are reviewed and accepted by EPA for final processing.
- Funds available for training are released before September 31st, 2022.
- FY23 Job Training RFA and due date will be announced.

#### October 2022

- Look forward to an HMTRI in person Annual All Grantee Meeting in Alexandria VA.
- Hotel and conference costs will be covered with participants paying for transportation, meals and incidentals.

### Winter 2022- 2023

- Initial cohorts begin with program refinements, partnership development and placement continuing.
- Training and placement continue with ACRES reporting quarterly.
- Consideration regarding program expansion, improvement and sustainability continue.

#### 5. Revisiting the HMTRI Mid-Year Brainstorming Workshop

In today's PLC we wanted to spend some time discussing the November 17<sup>th</sup> Virtual Mid-Year Brainstorming Workshop. The Mid-Year Brainstorming Workshop was slightly different than many technical assistance-related virtual events being offered. The goal of this workshop was to network a small group of participants, get to know each other and perhaps leave with some thoughts and ideas that can be incorporated into job training programs. To achieve these objectives, we followed the following guidelines.

- The approach to the workshop was to present an unstructured event without presentations, identified presenters, or PowerPoints.
- To maintain a brainstorming atmosphere, participants were provided an agenda with general topics for discussion in advance.
- In efforts to broaden participant contributions, breakouts were limited to twenty participants. maximizing peer to peer contributions. Every participant was encouraged to participate.
- Breakout participants were curated and preassigned to ensure experienced grantees were matched with less experienced grantees.
- HMTRI facilitators were used to keep discussions lively and moving. For each general topic, four questions
  were posed as discussion starters. Facilitators acted as timekeepers limiting comments and ideas to less
  than seven minutes for each talking point.
- Experienced grantees were recruited as recorders capturing innovative ideas and strategies to share during a plenary session.
- Discussion topics were limited to three critical topics currently confronting JT grant recipients.
  - Promoting Environmental Job Training Programs
  - o Community Engagement and Partnership Development
  - Student Retention and Graduate Employment

At the conclusion of breakout sessions, the most innovative and interesting ideas were presented and discussed in a plenary session. As with previous agendas, after hours videos of grantee programs allowed workshop participants an opportunity to visit other JT programs and facilities. Based on the post meeting evaluation, we felt the Mid-Year Virtual Brainstorming Workshop was successful and useful to those attending. The success of the informal workshop has prompted us to use the same format at the next Mid-Year meeting tentatively scheduled

for early May. HMTRI will provide a detailed evaluation report for those interested. Here are a few of the summary comments presented as part of the evaluation.

- Just good to hear about what the entire field is dealing with
- Sharing of practical ideas
- Learning from others
- Since we just launched our first cohort, it was inspiring to see and hear about success stories and longterm successes
- Being able to engage with everyone
- The videos were a special part of the workshop
- Talking and sharing with peers
- All the video presentations showed what others are doing
- Informal nature of the conversation
- The networking and sharing best practices
- The facilitator, Nolan was great
- Opportunity to interact with other grantees and hear success stories

Here are a few examples of ideas presented during breakout sessions. The December issue of CONNECT News details breakout ideas under each of the topics addressed. A copy of that issue will be posted on the HMTRI website and is also available by returning this email with a request for the December CONNECT Newsletter.

- Offer hot meals and snacks to support retention
- Use community service projects to get the students out in the field doing things
- Student tracking- Frequent contact and support, make sure student is okay and employer is happy
- Ask graduates to come and speak with new students
- Think about the length of the program and how it affects your students –finances may not permit longer training cohorts
- Use an interest profiler to identify applicants who will be good candidates
- Bad apples ask them to leave, connecting them to support services
- Provide conflict resolution during peer-to-peer meetings
- Invite employers to the advisory board and to attend mock interviews
- Establish internships with employers
- Teach students how to sell themselves during job interviews, interviewing is huge
- Build self confidence in students through mentoring
- How to hook the student determine topics that peak their interest, life skills or other
- Using screening to set clear expectations before entering the program
- Approaching bad apples one on one time with mentoring, peer partnering, reminding them why they're involved in the program. Offer wrap around services without it feeling like a handout
- Provide trauma informed training for staff to deal with PTDS and bipolar issues
- Creating feedback loops with employers, using activities to showcase the program and its accomplishments
- Presenting students to employers by focusing on strengths, growth, accomplishment

# **Clearing Out the Superfund Backlog.**

EPA Announces Plans to Use First \$1B from Bipartisan Infrastructure Law Funds to Clear Out the Superfund Backlog. The U.S. Environmental Protection Agency (EPA) announced a \$1 billion investment from the Bipartisan Infrastructure Law to initiate cleanup and clear the backlog of 49 previously unfunded Superfund sites and accelerate cleanup at dozens of other sites across the country. Until this historic investment, many of these were part of a backlog of hazardous waste sites awaiting funding. Thousands of contaminated sites exist nationally due to hazardous waste being dumped, left out in the open, or otherwise improperly managed. These sites include manufacturing facilities, processing plants, landfills, and mining sites. The \$1 billion investment is the first wave of funding from the \$3.5 billion in the Bipartisan Infrastructure Law to help clean up polluted Superfund sites in communities. The backlog of previously unfunded sites that will now be receiving funding are in 24 states and territories and all 10 EPA regions, including some communities who have been waiting for cleanup for more than four years. # LCI Aims to Help Shape President Biden's Justice40 Initiative

President Joe Biden ordered federal agencies to direct 40% of the government's investments in climate and clean infrastructure to benefit people in disadvantaged communities. Implementing the directive will not be simple, but a new report by scholars from the University of California Los Angeles Luskin Center for Innovation (LCI), advised by environmental justice leaders, provides a framework that federal officials could use to maximize Justice40's impact.


